The Sierra Arts and Crafts Festivals are displays of local and regional talent. Exhibitors include artists and craft persons and/or their chosen representatives for all media of original Fine Art and Fine Crafts. We encourage the artists to be present during the Festivals, but will accept specified representatives under certain conditions.

Items for sale during the Festivals must be produced under the direct supervision of the original artist. Mass produced retail items are not allowed. Typical reproduction techniques for art are permitted. The artist or qualified representative should provide proof of authenticity.

Participants must have their own display. Spaces are outside and 10' x 10'. Each participant is responsible for the safety and protection of their own exhibit and merchandise. The KRVA, the Town of Kernville or the Kern County Parks are not responsible for loss or damage to participants' merchandise. Overnight security is provided.

Spaces are on a first-pay basis. Entry fees are \$125.00 for KRVA members and \$150.00 for non-members (this includes your membership). Membership fees per year are \$25.00 per person of \$35 per couple. If you are a new participant, you will be asked to submit 3 photographs of your work, a photo of your display and a copy of your California Resale License. Once you are accepted into the festival, your fee is not refundable.
